Subject: Experience with DE-KA Pain Reliever

Dear Mr. Deinlein-Kalb!

I have been using the apparatus for several years due to frequent pains in lumbar vertebra and in my left shoulder. I am 79 years old; the causal therapy is not applicable, and the only way remains is the symptomatic treatment. The parallel acupuncture helps to reduce the pain. I treat myself with the help of the DE-KA apparatus in cases of acute pains in the region of my head and neck which is usually caused through weather conditions. Therefore, I put the wrist for 5 minutes on my arm. The duration of the pain reduction takes 2 to 5 hours and depends on the situation. The suggested indirect treatment at night by applying the apparatus with elastic bandage on the vein of the left arm works well. I didn't try to connect the electrodes. Instead, I wrapped the apparatus on the plain side with adhesive plaster in order to prevent its movement while attached to the body. The attempts to fix the apparatus on critical places such as the shoulder joints didn't work. I got rid of strong medicaments (with side effects and adaption time) thanks to both therapies (DE-KA and acupuncture); what is left is the daily dose of 1-2 pills of Thomapyrines. You are welcome to use my experiences anytime (I am a graduated psychologist and have a Ph. D in Science). Please let me know of new field reports about DE-KA or other products in the future.

Subject: Pain reliever DE-KA - Titan

Mr. Deinlein-Kalb,

I have been using your apparatus since May 13, and I am very thankful for it. Nearly everyone can apply it in cases of pain. I am one of the persons who are suffering from chronicle diseases and my pains won't go away since 15 years now.

The pains I am suffering from:

Nearly every year pains in intervertebral cartilage, in loin, (LWS5/S1 – can't be operated)

Sciatica from both sides (every day)

Arthrosis in sacrum joint

I am wearing the pain reliever nearly every day and night: during the day on the wrist and during the night on the loin. Patient's medical history

Subject: Pain - cancer

1950: born

1973: married

1983: birth of the first child

1987: birth of the second child

1991: diagnosis: invasive, adenoma of prostate -Ca. II-III level/degree

Tumour of mammary gland with close-by and distant to the left, and the description of breast biopsy to the right.

Treatment: Zoladex, 6 courses of chemotherapy with CMF

1994/1995: metastases in bones from BWK 11(thoracic vertebra) LWK 3(basilar vertebra), sacrum, LWK 4(basilar vertebra)

Treatment: Irradiation

1996: husband's death

1997: metastases on the left side of sternoclavicular joint

Treatment: Irradiation

06/1999: Bone metastases in sternum

Treatment: Irradiation

08/1999-09/1999: Metastases in iliac bone from left side, in aitchbone

Treatment: Irradiation

10/1999-12/1999: metastases in brain and in vertebral artery

Treatment: Irradiation

01/2000: Post operated pains:

Metastatic disease in all organism from vertebral artery dissection (HWS) to aitchbone.

Epidermoid cancer with metastases in HWK 4(cervical vertebrae), BWK 11(dorsal vertebrae), LWK 2(lumbar vertebrae).

Patient with acute pain in the back and symptoms on paralyzed legs.

Treatment: 2 times a day Tramal ret. 150 mg, all 4 hours. 40 drops, drops

Novaminsulfonratiopharm

From 2000 on: additional use of DE-KA-Titan- pain reliever (this apparatus can be worn on the wrist like a watch)

Result: great reduction of pain in and around metastases; the symptoms of the paralyzed legs have decreased after 2 weeks using the DE-KA pain reliever with 4 electrodes. Thus, the pain reliever Novaminsulfonratiopharm was not needed any more. The pain reliever was introduced in a clinic in Regensburg in 2000, in the department of radiation therapy.

At the same time information about the pain reliever was passed to Doctor Michael and Regina Lauterbach in their practice in Kiel.

02/2000: Due to progressing metastases in bones, the patient had to take CHT (6 cycles) 5 Fluorouracil + Navelbine. Thus, the pain in the back and sacrum was relieved and the Pain reliever wasn't used any more.

04/2000: Pain in the mentioned area came back again. The DE-KA Pain reliever was used regularly since then with the same good results as in 01/2000.

The patient is completely convinced of the high effectiveness of the DE-KA Pain reliever.

Nuremberg, 05-01-00. Additionally:

05-07-00: Due to the repeated positive results with the DE-KA pain reliever, Mr. Deinlein-Kalb recommends the patient to wear the apparatus 23 hours a day.

06-16-00: The patient reports: I feel good after my 4th chemotherapy. The pain reliever is on me the whole day and night; I don't take pills any more.

Subject: Apparatus - DE-KA - Titan

Dear Mrs. Festl!

Recently you told me during our telephone conversation about your desire to receive our responses about the apparatus (now DE-KA Titan). Here it is.

The DE-KA Titan gives excellent results: I tried it on myself as I suffer from chronic back pains after a herniated vertebral disk. For the first time after 4 years of ineffective treatment with acupunctures, massages and constant injections, my pain was relieved completely. This is the very positive aspect of the apparatus. Nevertheless, there is also a negative one: the electrodes for long term treatment (this is usually the case) are absolutely not proper. Firstly, stickiness exhausts after 3 days. Secondly, the cable releases from the electrodes after the third or fourth day of usage (in the night!) and it is not possible to fix them permanently again. The rubber electrodes should be delivered with plugs for sockets as used in TENS-apparatuses. In addition, I would recommend adhesives or tapes.

However, I proofed the great effect of the apparatus once again today. Both electrodes from the package exhausted after a week and as a consequence, my pain came back again. I want to help myself tomorrow. Therefore, I'm going to try to apply the old electrodes from the TENS-apparatuses on the DE-KA apparatus.

A better solution for this problem would surely help promoting the spread of the apparatus. Please let me know about this, if it will be the case sometime.

My name is Jerzy Wojtasiewicz, I am 60 years old. I live in Poland, in Trachy near Gleiwitz.

I am a pensioner-invalid for already 12 years and I receive persistent treatment. My main problem is the spine. It was simply already used too much and at several places there has come to some big dislocations. Since several years I also had some changes in my shoulders and hands. In some years my operation will be unavoidable. It is, however, a very complicated operation and the positive result is not always guaranteed. As long as I can go, I will not make the operation, because if something goes wrong, I will probably have to use the rocker.

My illness is, of course, connected to very acute pains. I have been already taking pain-relieving medicines for 15 years and I am staying under the influence of stronger and stronger pain-killers for 5 years.

In 21.03.2008, I got DeKa-Titan to test it. I felt its effects already after 30 minutes. On this date I took my last pain-relieving tablet. I use this apparatus with an electrode, which I clay on the upper part of the spine. It is enough. Only by faster movements do I feel short-term and small pains. However, the most important thing for me is that the prolonged pains, which didn't stop completely in the last time even after taking pain-relieving drugs, went away and I don't feel them any more.

I can live normally again.

Tendonitis

To: DE-KA

I wanted to give you details on my experience using the DE-KA Titan for pain management. I'm normally a very healthy person, but this year I experienced sustained pain in my right shoulder and arm and after several weeks went to an orthopedist to find out what was wrong. After x-rays and an MRI, the diagnosis was tendonitis and it was treated with cortisone to reduce the inflammation. However I was left with a condition called "frozen shoulder" which severely limited the use of my arm due to the decreased range of movement.

The treatment for the frozen shoulder is intensive physical therapy and there are a lot of aches and pains that go along with the condition and treatment, as well as the residual pain from the tendonitis. The DE-KA Titan has helped me so much to get through the pain with this process so far (I've used the DE-KA Titan for about 4 weeks) – at this time I'm still going through physical therapy and wearing the DE-KA Titan. In the beginning before using the Titan, I was taking aspirin every 4 hours to help with the pain (I refused the pain medication prescription from the doctor as my body doesn't react well to them.) and since starting to use the DE-KA Titan I haven't had to take a single aspirin.

One additional note on the Titan is regarding my husband, George, who is now retired. George was a professional firefighter for 38 years and as a result has some physical issues that cause him pain: knee surgery for a torn ligament and compressed disks in his neck. One night after I came home from the office, George commented to me that his "knee was killing him" due to the rainy weather and I suggested that he try my DE-KA Titan. Thirty minutes after George started to use the Titan, he told me his knee wasn't bothering him. Several weeks later, he was having some back pain and couldn't sleep and he borrowed my Titan again. Once again the Titan helped George with his pain and he got a good night's sleep. Now when he gets pain in his knee or back, he asks me if I need my Titan. I don't mind sharing with my husband, but the optimum solution was a second Titan for my home so no one has to go without.

Before this experience I never had to deal with prolonged pain, so the DEKA Titan has been a real help to me. Just like the DE-KA web site video states: "LIFE IS BETTER WITHOUT PAIN"!!
